

ENTRY VISA

Eligibility Criteria

1. The applicant is a person OF INDIAN ORIGIN, defined as a person who has **HELD INDIAN NATIONALITY**, or a **CHILD OR GRANDCHILD** of a person who has held Indian nationality
2. **Applicant is a spouse or child** of a person of INDIAN ORIGIN.
3. Applicant is a **spouse or dependent family member of a FOREIGN NATIONAL** coming to India on **long term visa** such as **Employment, Research or Student**. In such cases, the visa duration granted is co-terminus with the period of the principal visa holder.
The principal visa holder's visa must be issued before the spouse and dependent family members can apply for their Entry visa.
4. Applicant's **purpose of visit** to India **does not match any other type of visa**. In this the purpose of visit should be clearly explained.

US Passport Holders – Minor–Entry Visa

- ✓ The documents in the Checklist are mandatory for your application to be processed.
- ✓ This list of documents is not exhaustive and is subject to change based on the requirements of the Indian Embassy / Consulate.
- ✓ The Indian Embassy / Consulate have the right to request for additional documentation.
- ✓ 2 copies of signed Checklist with the boxes ticked must be submitted with your documents
- ✓ Wherever parent's sign, the signature must match with the passport signature. Applications will be put on hold and a new application will be asked for if parent's signature does not match with the passport signature.
- ✓ All copies requested should be clear and eligible.
