ENTRY VISA

Eligibility Criteria

- 1. The applicant is a person <u>OF</u> **INDIAN ORIGIN**, defined as a person who has **HELD INDIAN NATIONALITY**, or a **CHILD OR GRANDCHILD** of a person who has held Indian nationality
- 2. Applicant is a spouse or child of a person of INDIAN ORIGIN.
- 3. Applicant is a spouse or dependent family member of a FOREIGN NATIONAL coming to India on long term visa such as Employment, Research or Student. In such cases, the visa duration granted is co-terminus with the period of the principal visa holder.
 - The principal visa holder's visa must be issued before the spouse and dependent family members can apply for their Entry visa.
- 4. Applicant's **purpose of visit** to India **does not match any other type of visa**. In this the purpose of visit should be clearly explained.
